

PROJECT OVERVIEW

The Town is implementing a sewer extension project that will connect homes in five (5) areas of Nantucket to the Surfside Wastewater Treatment Facility (WWTF). The information below seeks to provide residents with answers to some basic questions (**WHO, WHAT, WHERE, WHEN & WHY**) on the project. The question of **HOW** will be addressed later in this series of informational newspaper articles.

WHAT IS THE PROJECT?

As per Articles 18 & 19 of the April 2016 Annual Town Meeting, the Town is implementing a sewer extension project that will connect homes in five (5) needs areas of Nantucket to the Surfside WWTF.

WHY IS THIS PROJECT NEEDED?

Several years ago, the Department of Environmental Protection required the town to evaluate wastewater management in all areas tributary to the Surfside WWTF. The resulting Comprehensive Wastewater Management Plan (CWMP) recommended extending sewers to these areas for continued environmental protection of Nantucket Harbor and other water resources in Town.

WHERE ARE THE PROJECT AREAS?

The five (5) areas are the Nantucket Harbor Shimmo area and four (4) Plus Parcel Areas as follows: Meadow View, Green Meadows, Bayberry and Tashama/MacLean areas.

WHEN WILL THE PROJECT HAPPEN?

The project is currently in the final design and permitting phase with advertisement and public bidding scheduled for Spring 2017. The bid process will result in a competitive price for the construction work, which is expected to begin in mid-September 2017. Construction will pause if needed to avoid the summer 2018 season.
